ORDER

With reference to the orders issued in the G.O. read above, the Accountant General has sought clarification on some points. Government are pleased to issue the following clarifications:—

(i) Charge Allowance:

There may be cases where officers were in receipt of charge allowance under Rule 53 Kerala Service Rules on the date of option to the revised scales. The quantum (i.e., the amount) of charge allowances already sanctioned should not be revised retrospectively based on the minimum of the revised scales of pay.

(ii) Military service of Civil Servants:

One year of active military service under National Emergency (Chinese Aggression) will be reckoned as two years for the purpose of increments of pay in State service (Vide G.O. Rt. No. 3012/74/PD dated 14-6-1974). This military service will not be so doubled for the purpose of weightage in the fixation of pay in the revised scales. Actual period of service alone will be reckoned.

(iii) Officers entitled to rent free quarters or an allowance in lieu thereof.

The Accountant General has requested that a list of Officers (including Police Officers) who are entitled to rent free accommodation may be forwarded to his office to enable correct authorisation of House Rent Allowance and that pending finalisation of this issue, the Controlling Officers may be instructed to issue a certificate to such of these officers who are not provided with the facility to the effect

that they are not provided with rent free quarters and that the other conditions prescribed in this regard from time to time by Government are satisfied. The Heads of Departments are requested to forward the list to the Accountant General and issue the certificates as required by him.

(iv) Dearness Allowance from 1-1-1974 and House Rent Allowance from 1-4-1974.

In partial modification of para 3 of G.O. (P) 122/74|Fin. dated 22-5-1974, Government are pleased to order that "Pay" for the purpose of determining the amount of Dearness Allowance from 1-1-1974 and the House Rent Allowance from 1-4-1974 will include Special Pay and Personal Pay, both in the revised scales and in the pre-revised scales, provided such Special Personal Pay counts for Dearness Allowance and House Rent Allowance under the existing orders|rules.

(v) Special Pay and Compensatory Allowances:

No special pay or compensatory allowance has been revised or withdrawn in the pay revision orders. All items of special pay are being subjected to a *de-novo* examination and pending issue of orders, after such examination, the special pay and compensatory allowance already sanctioned, will continue as under the existing rules|orders and will not be affected by the pay revision orders, except to the extent that the existing amounts (i.e., quantum) of special pay and allowances, sanctioned as a percentage of the basic pay, will not be enhanced, as a result of pay revision, until otherwise ordered.
