The Director of Sainik Welfare, as per the letter read as 3rd paper has reported that during the occasion of 'Kargil Vijay Diwas' on 25.7.2011 the Hon'ble Chief Minister has announced Cash grant of Rs.2000/- each to war widows of Kerala, as financial assistance from State Military Benevolent Fund. Subsequently the Director of Sainik Welfare has initiated proceedings for the disbursement of amount and requested Government to ratify his action.

As per the Rule 7 (b) of Government Order read as 2nd paper in special cases the president of Rajya Sainik Board (Chief Minister) can sanction upto Rs 4000/- as financial assistance from State Military Benevolent Fund. In the circumstance, sanction is accorded for the payment of financial assistance of Rs 2000/- (Rupees Two Thousands only) each to War Widows belong to Kerala from the State Military Benevolent Fund subject to ratification by Rajya Sainik Board. Being the Secretary to Rajya Sainik Board the action of the Director of Sainik Welfare in having issued proceedings directing all the Zila Sainik Welfare Officers in disbursing the amount is ratified. The Director of Sainik Welfare is instructed to receive


application from War Widows, process the same and publish the list of beneficiaries in the concerned Zila Sainik Welfare Offices within one month and to disburse the amount within two months from the date of this order and to place the expenditure for ratification in the next Rajya Sainik Board meeting.
