

# House building grant-Enhancement of annual income limit to war disabled ex-servicemen and the dependents of war casualties

## ORDER

In the G.O. read as 4th paper above, Government have ordered that the annual income limit of the ex-servicemen, widows of jawans killed in action and died in harness is enhanced from Rs. 12,000 to Rs. 25,000/- for the purpose of availing House building grant.

- The Director of Sainik Welfare as per the letter read as fifth paper above has reported that as per G.O. (MS)40/90/Hsg dated 18-9-90 after considering various aspects, Government was pleased to order that the income ceiling is not applicable to the dependents of jawans killed in action and jawans disabled in action and thus boarded out of service. But while enhancing the annual income limit as ordered in the G.O. read as 4th paper, war widows and war disabled are also included under income limit. The Director of Sainik Welfare has thereafter requested to Government to exempt the war widows and war disabled ex-servicemen from the annual income limit ordered in the above G.O.
- In the above circumstances reported by the Director of Sainik Welfare, Government have examined the matter in detail and are pleased to order that the income ceiling mentioned in the G.O. read as 4th paper is not applicable to the dependents of jawans killed in action and jawans disabled in action and thus boarded out of service
- The G.O. read as 4th paper above stands modified to this extent
