NOTIFICATION

S.R.O. No. whereas application has been made to the Government of Kerala under clause(a) of sub-section (1) of section 6 of the Charitable Endowments Act, 1890(Central Act 6 of 1890), by the administrators of the Endowment Fund known as "Amalgamated Fund for the Reconstruction and Rehabilitation of Ex-servicemen" for modifying the scheme settled for administration of the said Fund published under notification G.O.(P) 88/77/GAD dated the 10th March, 1977 at pages 1 to 6 of Part I of the Kerala Gazette No.16 dated the 19th April, 1977 as subsequently amended;

Now, therefore, in exercise of the powers conferred by sub-sections (2) and (3) of section 5 of the said Act and with the concurrence of the administrators of the said Fund, the Government of Kerala hereby make the following modifications to the said scheme and 22.7.1986 as the date on which the scheme as so modified shall come into operation namely:-

MODIFICATIONS

In the said scheme, in sub-clause(a) of clause 6 for items 1 to 7 and the entries against them, the following items and entries shall be substituted namely;

- 1 Governor - Chairman.
2. Chief Secretary or a Senior Officer of the State Government of the status of Secretary deputed by him as his representative. - First Vice Chairman.
3. Flag Officer Commanding-in-Chief, Southern Naval Command, Cochin. - Second Vice Chairman.
4. Air Officer Commanding-in-Chief, Southern Naval Command, Trivandrum. - Third Vice Chairman.
5. Addl. Secretary in the Ministry of Defence, Government of India, New Delhi. - Member
6. Two Ex-service Officers residing in the State nominated by the Chiefs of Staff Committee. - Members.
7. Persons not exceeding two in number having interest in the welfare of ex-servicemen nominated by the State Government. - Members.

The G.O.6th read above stands modified to the above extent with effect from 22.7.1986.
