NOTIFICATION

WHEREAS application has been made to the Government of Kerala under clause (a) of subsection (i) of section 6 of the Charitable Endowments Act, 1890, (Central Act 6 of 1890), by the administrators of the Endowment Fund known as "the Amalgamated Fund for the Reconstruction and Rehabilitation of Ex-servicemen" for modifying the scheme settled for administration of the said Fund, published under G. O. (P) No. 88/77/GAD dated, the 10th March, 1977, at pages 1 to 6 of Part I of the Kerala Gazette No. 16 dated the 19th April, 1977:

Now, THEREFORE, in exercise of the powers conferred by subsections (2) and (3) of section 5 of the said Act and with the concurrence of the administrators of the said Fund the Government of Kerala hereby make the following modifications to the said scheme and appoint the 10th March, 1977, as the date on which the scheme as so modified shall be deemed to have come into operation, namely:—

## MODIFICATIONS

In the said scheme—

(1) For clause 4 the following clause shall be substituted, namely:—

“4. *Corpus of the fund.*—The Fund which has been vested in the Treasurer of Charitable Endowments, shall consist of.—

(i) The Services Post-war Reconstruction Fund vested in the Treasurer of Charitable Endowments under G.O. (P) No. 140/PD dated the 16th May, 1969 published in the Gazette dated the 10th June, 1969;

(ii) The Special Fund for the Reconstruction and Rehabilitation of Ex-servicemen vested in the Treasurer of Charitable Endowments under G.O. (P) 140/PD dated the 31st March 1966 published in the Gazette dated the 19th April, 1966;

(iii) Contributions from.—

- (a) the defence budget of the Central Government;
- (b) the National Defence Fund;
- (c) the State Government;

(iv) any other donations and voluntary endowments which may be received from time to time;

(v) the income accruing to the corpus of the Fund and receipt on account of repayment of loans advanced from the corpus of the Fund”;

(2) for clauses 15 and 16 the following clauses shall be substituted, namely:—

“15. *Deposits and investment of the Fund.*—The Managing Committee shall invest a portion of the moneys of the Fund in any long term securities of Government of India or Government of Kerala or in any of the securities approved by Government, as may be considered appropriate by it in the name of the Treasurer of Charitable Endowments, Kerala.

16. *Operation of a joint account.*—The Managing Committee may obtain some amount of money in liquid cash from the Treasurer of Charitable Endowments for day to day requirements and deposit such moneys in one or more account of the State Bank of India or its subsidiaries or the Kerala State Co operative Bank Limited or the District Treasury or any Scheduled Bank, the deposit in which according to the last annual balance sheet are not less than Rs. 10 crores. Such account of the Fund shall be operated jointly by Chief Secretary to the State Government or a Senior Officer of the State Government of the Status of Secretary to Government deputed by him as his representative to the Managing Committee and the Director, Rajya Sainik Board on behalf of the Managing Committee”.
