EXGRATIA GRANT TO THE DEPENDANTS OF DEFENCE PERSONNEL KILLED IN ACTION

ORDER

As per Government Orders read as first and second paper above Government have issued Orders sanctioning immediate grant of Rs. 5,000 (Rupees Five thousand only) in each to the dependants of defence personnel killed/missing in action and exgratia grants varying from Rs. 1000 to 5000 to wounded/disabled service personnel in the conflicts of 1962, 1965 and 197.1 depending upon the degree of Disability. Subsequently, as per the G.O. read as third paper above, this benefit of exgratia was extended to the Central Para Military Force personnel who were killed/disabled in military operations belonging to Kerala and to the personnel of Central Para Military Forces killed/disabled while serving in Kerala, who belongs to other States.

- As per the G.O. read as fifth paper above, the benefit was extended to the dependants of Central Para Military Forces personnel killed in militant action and to those disabled/wounded in militant action.
- Government as per the G.O. read as fourth paper above, have enhanced the amount of exgratia to the dependants of deceased as Rs. 15000 and to those disabled to Rs. 5000–Rs. 15,000 depending upon the nature of disability.
- 4. The Director of Sainik Welfare in his letter read above has requested Government to extend the benefit to the category of defence personnel engaged in anti-militant/terrorist insurgency action.
- 5. Government have examined the matter in detail and are pleased to order that the benefit of exgratia grant accorded to the defence/CPMF personnel as per the Government Orders cited above are extended to defence personnel wounded in militant/terrorist action and to the dependants of defence personnel killed in militant action.
