ORDER

Appendix 1 of the Kerala Financial Code Volume II gives a list of Heads of Departments. The Accountant General has pointed out that this list needs to be updated, deleting some of the entries and adding new Heads of Departments.

2. Note 1 to Article 85 of Kerala Financial Code Vol. I gives the names of officers whose Travelling Allowance Bills do not require counter signature. The Accountant General has observed that this also requires updating, deleting entries such as Members of the Board of Revenue and including entries like 'Leader of Opposition & Chief Whip'.

3. The Government have examined the matter and are pleased to make the following amendments to the Kerala Financial Code:

- (1) Appendix 1 List of Heads of Departments of KFC Vol. II is replaced with a new list as at the Appendix to this Government Order.
- (2) The entry "(vi) Members of the Board of Revenue" under Note 1 below Art. 85 (a) of KFC—Vol. I shall be replaced by the entry "(vi) Leader of the Opposition and Chief Whip".

- (3) Item "(ix) Heads of Departments on Rs. 1050-1550 and above" under Note 1 below Article 85 (a) of KFC Vol. 1 shall be replaced by "(ix) Heads of Departments on Rs. 12600-15600 and above".
