O R D E R

As per Government Order read as first paper above the Kerala State Ex-servicemen Development and Rehabilitation Corporation (KEXCON) was formed with a view to implement schemes for the welfare and rehabilitation of Ex-servicemen and their dependents.

2. In the Circular read 2nd Government have issued instructions to all Heads of Departments, Public Sector Undertakings, Local Bodies and other Quasi Government Organisations and Establishments, asking them to approach the Corporation and receive security services sponsored by the Corporation only and, not from any other private agencies/Ex-servicemen sponsored by private agencies for any contract job/employment. It has also been instructed that they can terminate the existing contract of private agency as per the provisions of their contract and enter into contract with the Corporation, if so desired.

3. In the letter read as 3rd the Managing Director, Kerala State Ex-servicemen Development and Rehabilitation Corporation has reported that in spite of having clear directions to receive the security services sponsored by the Kerala State Ex-servicemen Development and Rehabilitation Corporation only, no Public Sector Undertakings, Local Bodies and other Quasi Government Organisations and establishments have approached them for security related services.


2. Government after having examined the matter in detail order that all Departments, Public Sector Undertakings, Local Bodies, other Quasi Government Organisations and establishments will engage the security personnel sponsored by the Kerala State Ex-servicemen Development and Rehabilitation Corporation only for the security related duties. The appointment of such security personnel sponsored by the Kerala State Ex-servicemen Development and Rehabilitation Corporation will be on contract basis.

5. The appointment of Security Guards made through the Public Service Commission will continue to be made in the institutions where the recruitment of such personnel are handed over to the Public Service Commission.
