Government, after consulting the Kerala Public Service Commission, order that Ex-Servicemen with not less than 15 years of military service and holding Indian Army Special Certificate of Education will be eligible for appointment to posts for which the prescribed minimum educational qualification is graduation, provided they have passed pre-degree/plus Two or equivalent examination in their Civil Education.
